Board of Directors

The One Southern Indiana (1si) Board of Directors governs the entire organization, which include the three pillars: Economic Development, Business Resources and Advocacy. The board is comprised of top business leaders who work toward proactively growing the region with the best interests of Southern Indiana in mind.

Economic Development Council

This council is devoted exclusively to the Economic Development side of the organization and is made up of the top investors who want to support the professional economic development services for Clark and Floyd counties, thus, paving the way for economic growth and opportunity.
